2. Tirahut Rural Municipality, Goithi, Saptari, Province no. 2 invites sealed bids or electronic bids from eligible bidders for the construction of **TIRAHUT/RURALMUN/SAP/NCB/WORKS01-2077/78** under National Competitive Bidding procedures.

If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 1000.00. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

6. Sealed bids must be submitted to the office Tirahut Rural Municipality, Goithi, Saptari, Province no. 2 by hand/courier or before **24/10/077**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **25-10-2077** at the office of Tirahut Rural Municipality, Goithi Saptari, Province no. 2. Bids must be valid for a period of **75 days** after bid opening and must be accompanied by a bid security, amounting to a minimum of **NRs. 250000.00**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
